Minutes from the Parish Council Meeting of Tuesday 15th June 2021

Mark Strange opened the meeting by giving a vote of thanks for Tony Williams and Jerry Stokes for their previous service as Chair and Vice-Chair, respectively.

- 1. Apologies: Jerry Stokes, Christine Nugent and Dom Morris
- 2. **Minutes:** Minutes of the Annual Parish Council Meeting held on 11th May 2021 were approved.
- 3. **Disclosure of member's interests**: Mark Strange declared an interest in planning item 15/01978/WCM.
- 4. **Dispensation requests:** None
- 5. Matters Arising: None.
- 6. Questions from members of the public: None.
- 7. **County Councillor's Report:** Not present.
- 8. District Councillors Report: -

Stephen Andrews reported -

- Fairford Town Council has been working with CDC to find locations for electric car charging points. CDC has found it difficult to find a contractor to do this with as most companies want to work with more densely populated areas. It is therefore unlikely for places outside of Cirencester to be considered.
- Overview & Scrutiny finished their report of the Tetbury and Fairford Leisure Centres. There has been some controversy over it. It only looked at the period up to the closure of the centres and not what happened after that. A number of lessons have been learnt, including how contracting out might be dealt with by the Council.
- There is a problem with water pressure at one end of Kempsford, apparently due to an issue at Castle Eaton. It was agreed that Tony Williams will write to Thames Water requesting clarification on the issue so residents can be informed.
- There have been complaints from other areas that dog waste bins are not being emptied. The Clerk advised that there have been no complaints from parishioners. When a request for two new dog bins was made to CDC they said no new bins could be installed at present as they do not have the capacity to collect any additional ones.
- Lakes 103 and 104 Planning enforcement are looking to see if tree protection is adequate. A landscape ecology management plan is going to be requested.
- The aim is for the Coln House planning application to go to planning committee as it involves community land with no ongoing use for the community. As GCC is the applicant and CDC the planning authority it is appropriate that the matter be considered openly in planning committee rather than delegated authority.
- The RAF planning application at Totterdown is now out for consultation. It is as anticipated from their briefing. One thing to be mindful of is that by changing the class to a military airfield it would bring lots of permitted development rights unless specific conditions are imposed.
- There is a proposal by the Boundary Commission to change the parliamentary constituencies which would result in one MP covering the Cotswold Water Park.
- It would be helpful if anyone can identify the pot hole on the Whelford Road that resulted in the cyclist's accident. Tony Williams will try to photograph it and send to Highways.

Steve Trotter reported -

- Sustrans were due to reply today about the feasibility study for the proposed multi-use path but it hasn't arrived.
- 9. Kempsford Parish Council

• **Review and adoption of new Standing Orders** – Council resolved to adopt the NALC model standing orders published in November with changes to Section 18. The Clerk to publish on website.

• Updates from meetings attended -

 Karen Saunders reported on the Kempsford Village Hall Committee meeting. There is a desire to get more community groups using the hall. Currently, government regulations only allow for a maximum of 25 people in the hall and 2 in the kitchen.

There is a problem with the entrance doors and recently a disabled person had difficulty accessing the hall to use the Post Office. A health and safety check will take place after Covid restrictions are lifted.

They have accepted the offer from a cleaning company within the village and will put a thank you in the Parish Newsletter.

A quote has been obtained to remove the outside play equipment and they have asked if CDC has a contractor they have used for this type of work – Stephen Andrews advised that this is not something the District Council would be involved in. A quote has also been obtained for tarmacking the car park. A 'clean-up' of the car park is taking place on Monday evening and they have advertised for volunteers on the Facebook page.

A meeting is scheduled for July to discuss the 5 year plan.

A donation has been received from The Friends of Fairford.

They will be contacting the Parish Council in order to obtain support for rate relief – Council suggested they attend a future meeting so the requirement can be discussed and understood.

- Transfer of Hazel View facilities it was agreed to start looking at establishing a management committee for the community facilities , linking in with the school and village hall to possibly raise further funding through CDC Crowd Funding facility.
- Teresa Griffin reported that Frank from Gloucestershire PROW had delivered a large scale map showing all the public footpaths in the Parish. He was asked about the road classification of Ham Lane from the Caddicks to Five Ways and this is being checked out with Glos. Highways.
- Tony Williams met with Dom Morris to show him around the Kempsford Quarries and lakes. The lake levels are decreasing now due to the pumping and the amount of geese and swans has reduced.
- **Grass Cutting at Kempsford** It was agreed to contact Westlea Landscaping to discuss either providing a lower cut or cutting more frequently.

• Residents reports to Councillors –

- Tony Williams reported receiving a number of complaints about the potholes on Ham Lane. He has reported it to Gloucestershire Highways and advised other residents to report it themselves.
- Tony Williams emailed Wiltshire County Council about the state of the Marston Meysey footpaths through Roundhouse Quarry.
